# Certificate of the right of permanent residence for Union citizens (EU/EEA) (Bescheinigung über das Daueraufenthaltsrecht für Unionsbürger)

Certificate of the right of permanent residence for nationals of the Member States of the European Union and the EEA (Iceland, Liechtenstein, Norway) Union citizens, who have continuously resided in Germany for five years and enjoy the right to freedom of movement, shall by rights acquire a right of permanent residence.

The certificate of permanent residence is purely declaratory and is irrelevant for a lawful residence. It is not necessary to exercise rights or to complete administrative formalities.

## Prerequisites

- **citizen of the EU or nationals of Iceland, Liechtenstein or Norway**
- **Residence in Germany stretching over several years with right to freedom of movement**

As a rule, 5 years' legal residence in Germany creates a right to permanent residence.

During this time a right to freedom of movement must have existed continuously, for example as an employee, self-employed person or non-employed person with sufficient means of subsistence.

Depending on the individual case, the time required in the Federal territory may also be less than 5 years.

- **Main residence in Berlin**
- **Personal appearance by appointment is required**

## Documents required

- **Form "Antrag auf Ausstellung einer Daueraufenthaltsbescheinigung" (filled out)**
- **valid passport or valid ID-card**
- **1 current biometric photo**

35mm x 45mm, frontal shot with neutral facial expression and closed mouth, looking straight into the camera, light background
- **Population register information (Melderegisterauskunft)**  
(<https://service.berlin.de/dienstleistung/120732/>)  
Proof of permanent residence in Germany must be provided. This is most easily done with an extract from the register of residents. Tax demands or similar may also be used.
- **Proof of the right to free movement (for the last 5 years)**
  - employees: current certificate from the employer stating the type and duration of employment
  - self-employed workers: business registration, tax number, current tax demand

- non-employed persons: proof of health insurance and means of subsistence

Additional documents may also be required.
