Place of activity in Berlin

Documents and translations

You must submit your documents in German. The translations must be done by publicly appointed or authorized translators.

Documents required

 Please use the deposited form.

Identity document

Identity card or other official identification document containing a photograph.

• Curriculum vitae

List in table form with your education and professional experience

Evidence of formal qualifications

Evidence of your education and training acquired abroad

• Certificate of professional experience

A certificate stating the nature and duration of the relevant professional experience

Where appropriate, a certificate from the State of training

If the profession is regulated in the country in which you have been trained: a certificate stating that you may practise the profession in the country in which you have been trained. This certificate must be issued by the competent authority in the country in which you are training.

 Declaration that you have not yet submitted a request for a determination of equivalence

Fees

- Mostly up to about EUR 600.
- The Chamber of Crafts will inform you about the costs. The costs generally depend on the amount of work involved and are due immediately upon receipt of the notification of fees.
- Additional costs may possibly arise for you (e.g. for translations or certification of your documents). These costs vary from case to case.

Average time to process request

- The Chamber of Trade will confirm that your documents have arrived after a maximum of one month. The Chamber of Crafts will inform you if any documents are missing.
- If all necessary documents are available, the procedure will take a maximum of 3 months. In individual cases the procedure can be extended once.
- For professional qualifications from the EU, the EEA and Switzerland, the procedure may be extended by a maximum of one month.

The Chamber of Crafts will provide you with advice even before the application is made and will identify the appropriate occupation in the craft trade sector for you. The Chamber of Crafts will inform you which documents you have to submit in original or as certified copy or as simple copy.
