# Activities exempt from the itinerant trade licence - application for exemption on special occasions

A itinerant trade licence is not required for anyone who offers goods for sale occasionally at trade fairs, exhibitions, public festivals or on special occasions with the permission of the competent authority.

This includes, for example

- the sale of Christmas trees or
- the sale of flowers and wreaths for Remembrance Sunday
- Events that are not regulated by the GewO.

## Prerequisites

- **No prerequisites necessary.**
- **For online applications: registration/login via BundID**

## Documents required

- **Identity document**  
Identity card or other official identification document with photo (not required for electronic application). Residence permit if the applicant is not a national of an EU country.
